Role-specific information

Role Summary

The role of the Research Assistant/Associate position is to carry out research on QD-on-Silicon PICs as part of the UK EPSRC QUDOS (QUantum Dot On Silicon systems for communications, information processing and sensing) project, which is looking to create a new era in optical integration so that all major photonic functions can be implemented on the QD-on-silicon platform.

University of Cambridge leads the task of system design, assessment and demonstration for demonstrating the potential of the monolithic integration technology for a range of applications across optical communications, computer networks and biomedicine. The RA will work closely with collaborators to develop QUDOS building blocks that involves Si, SiN, and III-V QD-on-Si, with the key technology step of developing a temperature-insensitive, low-reflectance, defect-free coupling interface between the III-V area and Si waveguides.

The RA will also work on developing integrated photonic switches for data centres that benefit from QD gain blocks and modulators, with low shuffling networks implemented using low-loss Si and SiN waveguide technology.

Appointment at Research Associate level is dependent on having a PhD. Those who have submitted but not yet received their PhD will be appointed at Research Assistant level, which will be amended to Research Associate once the PhD has been awarded.

The post will be held within the Centre for Photonic Systems in the Electrical Engineering Division of CUED. The Photonics Systems Research activity in the Department of Engineering was formed when Professors White and Penty joined the University of Cambridge in 2001. Since that time it has grown from approximately 15 people at its formation to more than 35 people now. It is part of a larger Photonics and Quantum Technologies activity (headed overall by Prof R Penty) within Engineering which incorporates the Photonics and Displays group (headed by Prof Daping Chu) and the Molecular Materials group (headed by Prof T Wilkinson).

The group carries out work in three main areas: (i) photonic communications, including quantum communications (ii) photonic components and integrated circuits and (iii) RF systems and sensing. This role is focused in photonic components and integrated circuits.

Whilst the post will be based in the CPS group, the postholder will be expected to develop links across the whole range of quantum technology and computing in Cambridge, and is therefore likely to work with researchers in Physics and the Department of Applied Maths and Theoretical Physics.
