

Purpose of the role

The Open Bioeconomy Lab, headed by Dr Jenny Molloy (openbioeconomy.org), is seeking a Postdoctoral Research Associate for OpenBioMAPS, a BBSRC Engineering Biology Mission Award developing open source tools for distributed biomanufacturing of enzymes and antibodies at low-cost using benchtop microbial and plant systems.

The overall goals of OpenBioMAPS are to work with UK biomanufacturing startups and SMEs to better understand their needs for next-generation, affordable technologies; seed a community of developers and users of open biomanufacturing tools; create training for academics and industry scientists to develop skills at the interface of biology and engineering; and use this as a springboard to run interdisciplinary miniprojects across the UK engineering biology community.

The role holder will:

• Characterise expression of protein constructs from the Open Yeast Collection in an OpenPichia chassis, inegrating yeast protein expression systems that can be freely distributed for commercial use.

- Support community-led development and characterisation of innovative DNA toolkits for protein expression in *Pichia pastoris*.
- Collaborate with Prof Jim Haseloff (Department of Plant Sciences) and Dr Matthew Wayland (Department of Zoology) on low-cost bioreactor and bioprocessing platforms.

In addition to opportunities to build a strong network within the UK biomanufacturing ecosystem, Open Bioeconomy Lab also coordinates a global network of researchers and SMEs through international meetings, journal clubs, workshops and training courses. The role holder will be expected to play an active role in working with these communities and other end users of the strains and DNA toolkits.

- conduct individual and collaborative research projects;
- write up research work for presentation and publication;
- continually update knowledge and understanding in field or specialism;
- translate knowledge of advances in the subject areas into research activity;

- assist in the preparation of proposals and applications to external bodies, e.g. for funding and contractual purposes;
- communicate material of a specialist or highly technical nature.

Teaching and learning support:

- may assist in the supervision of student projects;
- provide limited supervision/instruction to classes;
- may assist in the development of student research skills;
- may plan and deliver seminars relating to research area.

Liaison and networking:

- liaise with colleagues and students with the university and numerous industry partners, particularly startups and SMEs;
- build internal and external contacts

and participate in networks for the exchange of information and to form relationships for future collaboration.

 adopt a leadership role within the Reagent Collaboration Network (Reclone) for community-led development of innovative DNA toolkits for biomanufacturing.

Planning and organising:

- plan the use of research resources, laboratories and workshops as appropriate;
- plan and manage own research activity in collaboration with others;
- contribute to planning of joint research projects led by principal investigator.

Department of Chemical Engineering and Biotechnology



The Department of Chemical Engineering and Biotechnology at Cambridge has an international reputation for advancing molecular science and technology at the boundaries where chemistry, physics, mathematics, and biology meet. It is setting the pace for scientists, engineers, industrialists, and entrepreneurs to solve a range of complex global challenges across energy, the environment, and healthcare.

The Department has forged a number of significant industry partnerships and has pioneered the commercialisation of its cutting-edge research, recognising the vital relationship between knowledge transfer and economic growth.

The quality, depth and breadth of the Department's teaching have received international acclaim. Its training produces graduates of exceptional calibre with the vision and flexibility to apply their skills across a variety of fields and sectors, from commerce and high finance to industry and medicine.

Key information

The Department operates on the West Cambridge site. The department houses 30 academic, ~50 academic-related and assistant support staff, ~75 post-doctoral workers and ~150 research students. There are also ~50 MPhil students and ~150 undergraduates. The Department's research income was over £8.9 M in 2021-22. The department currently ranks 5th in the world in its discipline, and 1st in Europe (QS University rankings), and came second in the latest UK Research Excellence Framework Exercise (REF 2021).

The School of Technology

The School of Technology is one of the six Schools in Cambridge. It comprises: the Department of Engineering; the Judge Business School; the Department of Chemical Engineering and Biotechnology; the Department of Computer Science and Technology; and the Cambridge Institute for Sustainability Leadership. The School employs over 1,500 people and has a student population of nearly 3,300 (between undergraduates and postgraduates).

About the School Office

The School Office interfaces with a number of institutions both externally and internally, such as the EPSRC and the central administration. It has especially close contact with the Academic Division, Finance Division, the Research Office and Human Resources Division as well as the Departments within the School.

It is responsible for proposing, consulting and implementing School-wide polices and administrative procedures, ensuring compliance within the general governance framework, and financial control.

What we do:

• Finance: Supporting financially-informed decision-making and planning within the School and ensuring Financial Regulations and other policies and procedures are implemented and maintained at Departmental level. Supporting a range of Doctoral Training opportunities including the Centres for Doctoral Training and ICASE awards both funded by the Engineering and Physical Sciences Research Council (EPSRC), as well as the WD Armstrong studentship awards.

• Human Resources: Supports management and staff by providing HR management information; case support; guidance on the application of HR policies and procedures. The HR Business Manager takes the lead on significant HR projects and complex employment issues.

Terms of Appointment

Tenure and probation

Appointments will be made on a fixed -term basis for a period of six months, as your employment relies on the availability of finite funds for a specific purpose that are not part of the University's general revenues.. Appointments will be subject to satisfactory completion of a three-month probationary period.

Appointment at Research Associate level is dependent on having a PhD; those without a PhD will be appointed at Research Assistant level. Those who have submitted but not yet received their PhD will be appointed at Research Assistant level, which will be amended to Research Associate once the PhD has been awarded.

Hours of Work and Working Pattern

The hours of work for the position are 100% of full-time / 37 hours per week, working Monday – Friday. Conversations about part-time and other flexible working arrangements are encouraged at the University of Cambridge.


Working at the University
