Role Summary

The University of Cambridge is home to internationally renowned centres in construction engineering, including the Laing O'Rourke Centre for Construction Engineering & Technology (LORC), and the Centre for Smart Infrastructure and Construction (CSIC). This 1-year post will contribute to a dynamic research group in the area of data-centric infrastructure and construction. The successful candidate will have the opportunity to contribute to the development of a wide range of computer vision and deep learning technologies for tasks such as scene reconstruction, object identification, defect identification and digital twinning. This work will involve the design and development of new cutting-edge algorithms as well as their application to infrastructure and construction pain points.

A key feature of LORC and CSIC is their strong industry network and access to real datasets, and the successful candidate will be expected to leverage these benefits to ensure real-world impact. This position offers a unique opportunity to be at the forefront of transformative research in digital infrastructure. Importantly, this position will provide the successful candidate with the freedom to develop new and creative ideas, methodologies, and/or approaches in a supportive and collaborative team environment that is focused on ultimately improving real-world project outcomes. There will be ample opportunities to collaborate with international academic partners.

Appointment at Research Associate level is dependent on having a PhD. Those who have submitted but not yet received their PhD will be appointed at Research Assistant level, which will be amended to Research Associate once the PhD has been awarded.
